## AFFIDAVIT

1. That the Shaheed Smarak Education Society, Rampura Phul, Distt. Bathinda (Punjab)-151103, is a registered Society under the Societies Registration Act (XXI of 1860) and as amended by Punjab Amendment Act, 1957 vide Registration No. 100 of 2007-08 dated 03.01.2008.
2. That the Shaheed Smarak Education Society, Rampura Phul, Distt. Bathinda (Punjab)-151103, is of Non-Proprietary Character.
